## Terms and Conditions

1. To enjoy membership benefits and earn Steakholders Dollars you must be a member by enrolling at [www.steakholders.com.au](http://www.steakholders.com.au).
2. To earn Steakholders Dollars, you must quote your membership number when making a reservation and then present your membership card when settling the bill.
3. To earn Steakholders Dollars, the Steakholders Rewards Member must be paying the bill.
4. Steakholders Dollars are accrued on the basis of 8 cents (Steakholders Dollar) per AUD\$1 spent at any participating Steakhouse. The Steakholders Dollars accumulate and can be redeemed for a variety of different rewards. Members may earn Steakholders Dollars on this ratio AUD\$1 = 8 cents (Steakholders Dollar) for a maximum of 12 people in any one dining transaction (excludes gratuity).
5. In the instance that 13 or more guests are dining, the member can earn Steakholders Dollars yet the ratio is AUD\$1 = 4 cents (Steakholders Dollar) (excludes gratuity).
6. Only one reward can be redeemed at any one time.
7. All important notices will be communicated to members via Steak News e-mails. It is the responsibility of the member to ensure their e-mail address has been provided and is correct.
8. Steakholders Dollars cannot be accumulated on the reward redeemed.
9. Rewards redemptions cannot be used in conjunction with any other special or offer.
10. Any discrepancy will only be honoured upon presentation of the Steakhouse receipt/s.
11. In the event Steersons Pty. Ltd terminates the affiliation with any participating Steakhouse, Steakholders Dollars will not be earned for any transactions after the date that the Steakhouse ceases to be a participating venue. Kingsleys Australian Steakhouse King Street, Steersons Steakhouse Lime Street and Steersons Steakhouse Bridge Street will not be responsible for advising members of the termination of a Steakhouse affiliation with the program.
12. Steakholders Dollars cannot be credited retrospectively and can only be allocated to one account. Once Steakholders Dollars have been earned and awarded to one Membership Account, they cannot be transferred.
13. 2008-09 Steakholders Dollars can be accumulated from 1 July 2008 until 30<sup>th</sup> June 2009. Validity cannot be extended under any circumstance.
14. Members have up until the 30<sup>th</sup> June 2009 to redeem 2008-09 Steakholders Dollars. After this date, members can no longer redeem the previous year's Steakholders Dollars.
15. Steakholders Dollars cannot be rolled over to the following financial year. Steakholders Dollars start accumulating on 1<sup>st</sup> July 2008 and end on 30<sup>th</sup> June 2009.
16. There is an automatic membership renewal at the beginning of each financial year.
17. To redeem a Take Home or Dine In reward please call Head Office on 02 9295 5050 (during office hours). A minimum of one weeks notice is required to redeem these rewards.
18. Membership privileges will only be extended to the Steakholders Rewards Member. Members must identify themselves to the Steakhouse staff on settling the bill by providing their Membership Card for Steakholders Dollars accumulation purposes.
19. Membership benefits are non transferable, unless you have enrolled as a Steakholders Rewards Corporate Club Member. In regards to Corporate Club Members, we request that one nominated person within the organisation manages all Steakhouse reservations and reward redemptions. All communication from Steakholders Rewards will be sent to the nominated person within the organisation. Only one set of rewards will be offered per Membership at any one meal sitting.
20. Due to privacy laws, individual account information, including reward redemption details will not be given to anyone other than the member whose name appears on the account. This information will be delivered to the address recorded on the account at the time of the request.
21. Federal, state or other taxes resulting from Steakholders Dollars earned or redeemed are the sole responsibility of the member.
22. Steakholders Rewards reserves the right to cancel a Membership at any time if it appears that the Membership is being used in any other way than which the program is designed.
23.
